



## RULES

**ENTRY:** All contestants must complete an entry form and submit \$1,000 or more in donations to Inspirit to qualify to participate in Inspirit Idol "Karaoke for a Cause" event. All entries must be received by ~~March 20, 2009~~ **April 10, 2009**. Donations must be received by **April 15, 2009**. Entries postmarked, emailed or faxed after this date will not be considered.

**ELIGIBILITY:** \* You must be 18 years of age on or before April 25, 2009 and reside in Palm Beach, Broward, or Martin County and bring a photo ID to the event on April 25, 2009.

\* You will be ineligible to participate if you have entered into any of the following agreements on or before April 25, 2009: talent representation (for example, an agent or manager); a recording contract, an agreement relating to the use of your name, voice and/or likeness, an exclusive acting contract, or any other contractual agreement that would prohibit you from fully participating in the competition.

\* You are ineligible if you are an employee of Inspirit, or related to any one of the judges for this competition.

\* A maximum of twenty contestants will participate in the event held on April 25, 2009 and will be eligible to compete on a first come, first serve basis based on date entry form and donation is received.

\* Participation of contestants and their song selection will be confirmed by email on or before April 17, 2009

\* You must be a legal U.S. citizen or a legal permanent U.S. resident who is eligible to work full-time in the United States.

**JUDGING:** Contestants will be judged in three areas: Voice, Musicality and Stage Presence as interpreted by the judges. All decisions by the judges are final. The top scoring contestant will be awarded the Grand Prize. In case of a tie score, those contestants will be asked to sing a 2<sup>nd</sup> song, with the top scoring contestant proclaimed the winner. If the 2<sup>nd</sup> round results in another tie score, the contestant with the top scoring contestant in the Voice category will be awarded the Grand Prize.

**PRIZES:** The top scoring contestant will receive a certificate good for a six hour CD recording session at Elegbaland Studios located in Lake Worth, FL. The Inspirit Idol winner may schedule their recording session through Marc Ward any time in May or June of 2009 (his calendar permitting). Later dates can also be arranged. Renowned area engineers John and Bill Storch will mix and master the winner's recording soon thereafter, and deliver a finished master copy as part of the grand prize package. Other prizes will be awarded as part of the Grand prize and may be announced at the event or on the website. Prizes may also be awarded to 2<sup>nd</sup> and 3<sup>rd</sup> place winners. Winners will be responsible for federal, state and local taxes, sales taxes and any other fees that prizes may incur.

**DISQUALIFICATIONS:** We reserve the right to disqualify and/or exclude, in our sole and absolute discretion, any individual from the contest for violation of any portion of these rules or tampering with the entry process or who has engaged in conduct unbecoming of a representative of Inspirit, Inc. We also reserve the right to change the rules and procedures at any time to ensure

compliance with applicable law or ensure fair administration of the contest. All contestants must also wear acceptable performance attire or they will be disqualified at the event.
